Explain: **The project site is 12 acres consisting primarily of upland meadow/hay fields. One upland man-made ditch runs across the site from southeast to northwest for approximately 730 feet. This ditch was reported as a 0.1 acre wetland by the consultant. However, the ditch appears to have a bed and bank present. The ditch appears to have been constructed between 1998 and 2003 according to aerial photography. Prior, the entire site appeared to be upland**

agricultural ground. Additionally, one 0.9 acre upland man-made stormwater pond was observed on the site. The pond appears to have been excavated from uplands between 2003 and 2005, as residential subdivisions were being constructed to the west and south. According to the Shelby County GIS website storm sewer maps, the ditch drains to a man-hole feature, which drains into the stormwater pond. There is also a stormwater line coming from the north of the site that connects into the ditch and then into the pond. According to the stormwater sewer map structure elevations, the lines all drain to the pond, rather than north away from the site. The closest waters of the U.S. is Little Blue River approximately 0.75 mile north of the site and there is no evidence that the ditch or stormwater pond is connected to any waters of the U.S. As both the ditch and pond appear to have been constructed wholly in uplands, drain only uplands, and did not capture or relocate any waters of the U.S., they are not considered to be waters of the U.S.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
