Rationale: [Applicant is not contesting jurisdiction. These waters are known to have minimum intermittent flows. They are incised below the local high water table and are situated in an area that had expansive wetlands prior to settlement. Several field tiles also provide ground water source flows to many reaches of these waters. A check of aerial imagery found water flow in all above listed waters on February 28, 2005. The APT was run for that date and it was determined to be Normal Conditions.](#)
