Wetland 1	0.086 acre(s)	(b)(1) Non-adjacent wetland.	Wetland lies in a topographically low area in the middle of an agricultural field. It is neither adjacent to nor is inundated by an (a)(1)-(a)(3) water in a typical year. The nearest potential tributary is 0.5 mile to the west.
Wetland 2	4.1 acre(s)	(b)(1) Non-adjacent wetland.	Wetland lies in a regionally low area in the middle of an agricultural field. The nearest tributary is 0.3 miles to the west. Aerials indicate the wetland potentially continues off-site to the west, but does not appear to be continuous to the potential tributary. The wetland is neither adjacent to nor is inundated by an (a)(1)-(a)(3) water in a typical year.
