**B. Typical year assessment(s):** [APT was run for several dates due to one NWI signature present on the site at Data Points 2 and 3, and some observance of saturation in this area in older aerials. The APT for the consultants delineation date indicate conditions were slightly drier than normal, but PSDI drought index indicates mild wetness. However, review of recent aerials of 2018 and 2020, including August and September 2020, show that under normal typical year conditions, no evidence of saturation is present in this area. The site is entirely dry land.](#)
