B. Typical year assessment(s): The photos of the ephemeral streams identified as UNT West Fork Creek, UNT 1 Smith Creek, and UNT Halfmoon Creek that are included in the Waters Report were taken on May 4, 2020. Data from the Antecedent Precipitation Tool indicates that the photos were taken in the wet season in a period of drier than normal conditions. Although the conditions were drier than normal at the time the photos were taken, the drought index was extreme wetness. Since the photos were taken in the wet season, and the photos showed little to no flow, UNT West Fork Creek, UNT 1 Smith Creek, and UNT Halfmoon Creek were determined to be ephemeral.
