Wetland B	0.33 acre(s)	(b)(1) Non-adjacent wetland.	Wetland B is a forested wetland located in a wood lot along the south side of I-70. It is surrounded by upland agricultural fields to the west, south, and east. It is located over 1,700 feet from the nearest potential (a)(2) tributary. The wetland does not meet the definition of adjacent wetlands per 33 CFR 328.3(c)(1)(i)(ii)(iii) or (iv), and is therefore excluded per 33 CFR 328.3 (b)(1) as a non-adjacent wetland.
