Wetland 01	0.07 acre(s)	(b)(5) Ditch that is not an (a)(1) or (a)(2) water, and those portions of a ditch constructed in an (a)(4) water that do not satisfy the conditions of (c)(1).	Wetland 1 is a linear emergent wetland identified in a man-made excavated drainage ditch, which receives road drainage from SR 44. The ditch is not an (a)(1) or (a)(2) water and was not constructed in an (a)(4) water. Therefore, the feature is excluded.
Wetland 02	0.47 acre(s)	(b)(1) Non-adjacent wetland.	Wetland 2 is a farmed wetland located in a depression. The wetland does not meet the definition of adjacent wetlands per 33 CFR 328.3(c)(1)(i)(ii)(iii) or (iv), and is therefore excluded per 33 CFR 328.3 (b)(1) as a non-adjacent wetland.
Pond 01	1.37 acre(s)	(b)(8) Artificial lake/pond constructed or excavated in upland or a non-jurisdictional water, so long as the artificial lake or pond is not an impoundment of a jurisdictional water that meets (c)(6).	The pond is a man-made excavated feature. It drains out into a ditch that starts on the property line and flows south to Youngs Creek. This ditch is shown as an intermittent blue-line on the USGS topo. The pond is the headwaters of the ditch; there is no channel leading into the pond. Historical aerials indicate the site was entirely upland prior to excavation of the pond. Therefore, the pond is excluded.
Drainage Swale	587 linear feet	(b)(3) Ephemeral feature, including an ephemeral stream, swale, gully, rill, or pool.	The swale flows east/southeast into a stormwater drain. It does not exhibit a defined bed and bank. Therefore, the swale is excluded.
