The open legal drain ditch was previously a closed 14 inch and 15 inch tile. The tile was daylighted in 2018 and a ditch was constructed in its location. The ditch flows off-site to the east, where the headwater of East Fork Sly Run starts just downstream. The site was entirely upland prior to the ditch construction. As the ditch was excavated entirely in uplands, and it is not an (a)(1) or (a)(2) water, the open drain is excluded.
