For the 5/15/2020 delineation site visit, the data shows drier than normal climatic conditions during the wet season (see 2020-05/15\_APT Data.pdf). Therefore, delineation consultants observations and APT data indicate that the hydrologic conditions observed at the site for these dates is considered "typical year" conditions.
