- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Two isolated drainage features were identified on the 188-acre site. Drainage Feature 1 is located in the center of the forested area and measures 1,003 LF. The average width is 3 feet and depth 1 foot. Flow appears to be intermittent. Drainage Feature 1 begins from a field tile on the western edge of the woods and traverses east through the woods. It ends on the eastern edge of the woods where it enters a tile riser. Drainage Feature 2 is approximately 63 LF and appears to be an ephemeral channel that flows into Drainage Feature 1 in the woods. There are no USGS**

blueline features in the vicinity of the site. No drainage features are observed on the 1950, 1962, or 1972 historic aerials. No drainage features are shown on the 1979 USDA soil map. A review of the Johnson County Beacon GIS site does not show any mapped subsurface tiles on or near the site. There are no continuous surface channels, swales, etc. from where Drainage Feature 1 enters the tile riser to any downstream waters. The closest mapped waters of the U.S. appears to be Leatherwood Creek, which is 2,700 feet from the end of Drainage Feature 1. Therefore, Drainage Feature 1 and 2 do not have a surface or subsurface connection to any downstream waters, appear isolated, and are not considered to be waters of the U.S.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
