Stream 1 was identified as an ephemeral stream beginning at the eastern side of the site and extending west and then north. The stream appears to flow into an intermittent UNT to White Lick Creek north of the site. The stream bed is reported to be silt and leaf litter, with an OHWM depth of 8 inches and width of 2 feet. No basin information is available in StreamStats. Water was not flowing in the stream during the consultants delineation date during the wet season, under normal typical year conditions. Based on the physical conditions, typical year analysis, and site observations, this is an ephemeral feature and is therefore excluded.
Wetland A	0.068	acre(s)	(b)(1) Non-adjacent wetland.	The reported wetland is located greater than 500 feet from the nearest potential (a)(2) water and is not adjacent. The wetland does not meet the definition of adjacent wetlands per 33 CFR 328.3 (c)(i)(ii)(iii) or (iv) and is therefore excluded per 33 CFR 328.3(b)(1) as a non-adjacent wetland.
Wetland B	0.131	acre(s)	(b)(1) Non-adjacent wetland.	The reported wetland is located greater than 600 feet from the nearest potential (a)(2) water and is not adjacent. The wetland does not meet the definition of adjacent wetlands per 33 CFR 328.3 (c)(i)(ii)(iii) or (iv) and is therefore excluded per 33 CFR 328.3(b)(1) as a non-adjacent wetland.
Wetland C	0.035	acre(s)	(b)(1) Non-adjacent wetland.	The reported wetland is located greater than 1,000 feet from the nearest potential (a)(2) water and is not adjacent. The wetland does not meet the definition of adjacent wetlands per 33 CFR 328.3 (c)(i)(ii)(iii) or (iv) and is therefore excluded per 33 CFR 328.3(b)(1) as a non-adjacent wetland.
