C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The review area contains one emergent wetland that is dominated by cattails and reed canary grass. The wetland is located in a depressional area that does not have any hydrologic surface connection. A county tile historically ran from the property to the north, through the area where the wetland is located and continued to the southwest, out letting to McCoy Ditch. The tile failed many years ago and the county has not replaced the tile through the wetland. The county replaced the tile to

the southwest and connecting it to McCoy Ditch but did not connect it to the failed tile under the wetland. A site visit confirmed that the tile to the southwest had been replaced with new drop structures near the county road. The tile work stopped short of the wetland boundary with no drop structure or connection. Therefore, the wetland is not hydrologically connected to any waters of the U.S. and is considered an isolated wetland.
