Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Two isolated wetlands were identified within the project area (W-WRL-20210629-02: 0.51 acre - PEM; W-WRL-20210629-03: 0.18 acre - PEM). The wetlands were located adjacent to a utility substation. The isolated wetlands did not exhibit a direct connection to downstream surface waters. Small road side drainage ditches/swales run along Delaware Road. These features did not develop OHWMs and dissipated in crop fields and road side right of ways. Direct connections to downstream waters of the U.S were not present for W-WRL-20210629-02 or W-WRL-20210629-**

03. The substation was build on an upland ridge and the wetlands are shallow depressional areas adjacent to the electrical substation. A substation has existed at this location since at least 1955 (east side of road) and the area appears to have previosly been agriculture fields with no topographic support for jurisdictional waters. The wetlands likely developed in the area due to grading activities in vicinity of the substation.

Summarize overall biological, chemical and physical functions being performed: W-WRL-20210629-01 is marked by INDOT signs indicating that the wetland is part of a mitigation site. The agent stated that the area appears to be regularly saturated and supports obligate and FAC wet species. The agent also stated that based on topography, sheet flow is directed in the westward direction toward an NHD stream that is mapped approximately 16 feet to the west of the survey boundary and appears that the wetland abuts the stream.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: W-WRL-20210629-01 is marked by INDOT signs indicating that the wetland is part of a mitigation site. This area is in the northwest corner of the review area and appears to be regularly saturated and supports obligate and FAC wet species. Wetland W-WRL-20210629-01 is open to the west and based on topography, sheet flow appears to be directed in the westward direction toward an NHD stream that is mapped approximately 16 feet to the west. It is assumed that this wetland directly abuts the unnamed tributary to Bob's Creek and is therefore, a jurisdictional WOTUS.

W-WRL-20210629-02 and W-WRL-20210629-03 are isolated. Both are located within Duke Energy's maintained station footprint and surrounded by wide and developed maintained lawns or agricultural buffers. Both wetlands appear to drain to roadside ditches on either side of N Delaware Road. These upland drainage features are non-jurisdictional and were not observed to flow into jurisdictional waters.
