Explain: **A site visit was conducted on January 24, 2022 by Corps' personnel to verify the jurisdictional statuses of aquatic resources within the boundaries of the identified location. A feature identified as "Isolated Feature" displayed characteristics associated with an ephemeral tributary terminating in an enclosed constructed depression in the landscape. During the site visit, the feature was inspected by Corps' personnel and displayed no discernable outlet or**

drainage into other aquatic resources. The feature looked to be man-made and appeared to be too deep for agricultural use. Direct precipitation and adjacent surface runoff appeared to be the primary source of hydrology. The aforementioned aquatic resource does not possess any identifiable surface or shallow subsurface hydrological connections to a “Waters of the U.S.” The aquatic resource is not susceptible to use in interstate or foreign commerce and therefore not “Waters of the U.S.”.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
