C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. **ADDITIONAL COMMENTS TO SUPPORT JD:** There are three man made ditches with the review area. Two of the ditches which run parallel to Greenbelt Highway and Greenwood Road and measure 415 linear feet and 148 linear feet respectively. These features appeared to have been constructed in uplands prior to 1998 to drain stormwater from the adjacent roads. These features were dry during the December 2021 delineation. One man-made ditch is in the central portion of the project boundary and drains into Wetland 1. This ditch measured 50 linear feet appears to have been constructed between 2002 and 2005 as part of the development within the local area. Some surface water was observed near this feature's terminal point with Wetland 1, likely due to recent storm events, but otherwise was sloped upward, overgrown with vegetation, and did not appear to have a source of water such as a culvert or ground water. These ditches are man-made features constructed in the uplands. The wetlands are physically isolated in the landscape with no indication of consolidated flow leaving the wetlands boundaries towards the upland ditches. There are no RPW within the review area or in close proximity to the site. The review area is outside the 100-year floodplain of Mill Creek which is separated from the site by Green Mill Drive.
