### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

The Antecedent Precipitation was used to analyze the date of the applinat photo. The 10/23/2021 and 11/10/2021 photos were during normal conditions during the wet season .

Pond 1 (0.15 acre) The open water feature is isolated in the landscape and has no potential connection to downstream resources.

Pond 2 (0.16 acre) The open water feature is isolated in the landscape, outside the floodplain of Stream 17, and has no potential connection to downstream resources.

Pond 4 (0.17 acre) The open water feature receives flow from Stream 17 but has no outlet which could provide a potential connection to downstream resources.

Pond 5 (0.34 acre) The open water feature is isolated in the landscape and has no potential connection to downstream resources.

Pond 6 (0.28 acre) The open water feature is isolated in the landscape and has no potential connection to downstream resources.

Pond 7 (0.23 acre) The open water feature is isolated in the landscape and has no potential connection to downstream resources.

Pond 8 (0.59 acre) The open water feature is isolated in the landscape, and has no potential connection to downstream resources.

Pond 9 (0.18 acre) The open water feature is isolated in the landscape, and has no potential connection to downstream resources.

Stream 16 (163 feet) The ephemeral stream drains into Pond 4 which is an isolated non-jurisdictional feature.

Stream 30 (39 feet) The ephemeral stream loses a defined bed and bank and consolidated flow as it terminates. There is no indication of a potential nexus to Stream 29, or any other downstream resources.

Stream 32 (121 feet) The ephemeral stream loses a defined bed and bank and consolidated flow as it terminates. There is no indication of a potential nexus to Stream 25, or any other downstream resources.

Stream 33 (136 feet) The ephemeral stream loses a defined bed and bank and consolidated flow as it terminates. There is no indication of a potential nexus to Stream 25, or any other downstream resources.

Stream 34 (85 feet) The ephemeral stream loses a defined bed and bank and consolidated flow as it terminates. There is no indication of a potential nexus to Stream 25, or any other downstream resources.

Stream 44 (168 feet) The ephemeral stream loses a defined bed and bank and consolidated flow as it terminates. There is no indication of a potential nexus to Stream 41, or any other downstream resources.

Wetland B (0.15 acre) The palustrine emergent wetland is physically isolated in the landscape with no indication of a potential connection to Wetland A, Stream 1, or other downstream resources.

Wetland D (0.12 acre) The palustrine emergent wetland is physically isolated in the landscape with no indication of a potential connection to downstream resources.

Wetland H (0.04 acre) The palustrine scrub-shrub wetland is adjacent to Pond 6 but is physically isolated from any downstream resources.

Wetland K (0.12 acre) The palustrine emergent wetland is physically isolated in the landscape with no indication of a potential connection to downstream resources.
