C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Open Water 1: The feature is an abandoned limestone quarry pit constructed prior to 1985 which has formed into an open water feature. The feature is 120.5 acres, was constructed in the uplands and is isolated in the landscape with no outlets to downstream waters.

Open Water 2: The feature is an abandoned limestone quarry pit constructed prior to 1985 which has formed into an open water feature. The feature is 16.7 acres, was constructed in the uplands and is isolated in the landscape with no outlets to downstream waters.

Open Water 3: The feature is an abandoned limestone quarry pit constructed prior to 1985 which has formed into an open water feature. The feature is 38.4 acres, was constructed in the uplands and is isolated in the landscape with no outlets to downstream waters.

Intermittent 1: The stream is 1,985 linear feet and enters the site from a culvert beneath Bloomfield Road along the northern project boundary and flows south then southeast before terminating in a sinkhole with a ditch on the east side of the sinkhole. The ditch continues eastward, and Intermittent Stream 1 re-emerges from underground, likely via a seep. Intermittent Stream 1 then flows south into Open Water 3.

Intermittent 3: The stream is 20 linear feet and enters the site in the northern portion and flows east into Intermittent 1.

Ephemeral 1: The stream is 137 linear feet and exhibited flow only in response to precipitation. The stream flows directly into Open Water 1.

Ephemeral 2: The stream is 472 linear feet and exhibited flow only in response to precipitation. The stream flows directly into Open Water 1.

Ephemeral 3: The stream is 88 linear feet and exhibited flow only in response to precipitation. The stream flows through an agricultural field before it loses a defined bed and bank approximately 100 feet from Open Water 2 and is isolated in the landscape from any potential connection to downstream jurisdictional waters.

Ephemeral 4: The stream is 36 linear feet and exhibited flow only in response to precipitation. The stream flows directly into Open Water 3.

Ephemeral 7: The stream is 90 linear feet and exhibited flow only in response to precipitation. The stream flows directly into Intermittent 1.

Ephemeral 8: The stream is 18 linear feet and exhibited flow only in response to precipitation. The stream flows directly into Intermittent 1.

Ephemeral 9: The stream is 89 linear feet and exhibited flow only in response to precipitation. The stream flows directly into Intermittent 1.

Wetland 1: The 0.01-acre palustrine forested (PFO) wetland is in defined low-lying area near Open Water 1. The feature is isolated in the landscape and exhibits no potential direct or indirect connection to jurisdictional waters.

Wetland 2: The 0.016-acre palustrine emergent (PEM) wetland is located in defined depressions near a mine road and Open Water 1. The feature is isolated in the landscape and exhibits no potential direct or indirect connection to jurisdictional waters.

Wetland 3: The 0.066-acre PEM wetland is located in defined depressions near Open Water 2. The feature is isolated in the landscape and exhibits no potential direct or indirect connection to jurisdictional waters.

Wetland 4: The 0.125-acre PEM wetland is located in defined depressions near the origin of Ephemeral 2. The feature is isolated in the landscape and exhibits no direct or indirect connection to jurisdictional waters.

Wetland 5: The 0.076-acre PEM wetland is located in defined depressions adjacent to Ephemeral 2. The feature is isolated in the landscape and exhibits no direct or indirect connection to jurisdictional waters.

Wetland 6: The 0.031-acre PEM wetland is located in a low-lying drainage area between Open Water 2 and E John Rowan Boulevard. The feature is isolated in the landscape and exhibits no potential direct or indirect connection to jurisdictional waters.

Wetland 7: The 0.124-acre PFO wetland is located in a low-lying area near E John Rowan Boulevard and a mine access road. The feature is isolated in the landscape and exhibits no potential direct or indirect connection to jurisdictional waters.

Wetland 9: The 0.004-acre PEM wetland is located in a low-lying area between E John Rowan Boulevard and Open Water 3. The feature is isolated in the landscape and exhibits no direct or indirect connection to jurisdictional waters.

Wetland 12: The 0.005-acre PFO wetland is located in a depression near Wetland 11. The feature is isolated in the landscape and there is no indication of direct or indirect connection to PER 2 or other potentially jurisdictional resources. The feature is located outside the floodplain of PER 2 and is not adjacent to the feature.
