### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

D-1: The ephemeral stream measures 194 linear feet. As the stream travels down slope through the forested tract it loses a defined bed and bank. Flow from the stream does not consolidate down slope and reform a channel, and there is no indication of a direct or indirect connection to downstream aquatic resources.

Wetland A: The wetland measures 0.01 acres and is located in a low-lying area within an isolated forested tract surrounded by uplands. There is no indication of consolidated flow leaving the wetland, or a direct or indirect connection to downstream aquatic resources.

These features were determined to be isolated in the landscape, have no hydrological or ecological connection to Waters of the U.S. and are not susceptible to use in interstate or foreign commerce.
