Wetland B is located in an active row crop agriculture field and drains via sheet flow to Wetland A. Wetland A is located within an agriculture field and drains out of the review area via a culvert under U.S. 136. Wetland D is located within a row crop agricultural field and drains via sheet flow to**

Wetland C. Wetland C is located within a row crop agricultural field and directs drainage to an off-site vegetated swale along the north of U.S. 136. The vegetated swale directs drainage to the culvert under U.S. 136 associated with Wetland A. The culvert under U.S. 136 directs drainage flow to an off-site vegetated swale/roadside drainage along the south of U.S. 136. The roadside drainage does not develop stream or wetland characteristics at the culvert outlet or in the immediate vicinity of the culvert outlet. The drainage flow eventually sheet flows across a row crop agricultural field and appears to concentrate and develop stream/wetland characteristics approximately 200 feet down slope of the culvert outflow. The wetlands do not possess any hydrological or ecological connection to a downstream TNW, and are not susceptible to use in interstate or foreign commerce. Therefore, the wetlands are isolated.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: All drainage within the review area exits the site via one culvert under U.S. 136. The culverted drainage does not exhibit OHWMs or wetland characteristics within the vegetated swale/roadside drainage along U.S. 136. The vegetated swale/roadside drainage turns into sheet flow across a row crop agriculture field located south of U.S. 136. The crop field directs the sheet flow to the northwestern corner of the field where the drainage concentrates and eventually enters an unnamed tributary of West Fork White Lick Creek. The review site is separated from downstream jurisdiction features by non-jurisdictional swales/roadside drainages and sheet flow across crop fields. The wetlands do not possess any hydrological or ecological connection to a downstream TNW, and are not susceptible to use in interstate or foreign commerce. Therefore, the wetlands are isolated.
