If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The reported “Elongated Dry Detention Basin” was constructed in 2009 within dry land to detain stormwater from the adjacent residential development. Wetlands A, B, C, D, E, F, and G lie in agricultural depressions in a poorly drained field. These areas were previously inspected in 2018 and found to be either smaller at that time and/or transitioning to wetland. Due to lack of drainage improvements since 2018, Wetland G increased in size and Wetlands A-F developed. Wetland H formed within a stormwater basin constructed in dry land. Due to the lack of drainage of the “Elongated Dry Detention Basin,” hydrology was impounded, and wetland conditions developed. Wetland I formed within a basin constructed in 2009 when the adjacent residential developments were constructed. Wetlands H and I are contiguous with and flow into the reported elongated detention basin; however, the basin does not have an outfall under Boden Road. There are no possible surface or subsurface hydrologic connections from the wetlands, such as swales, drainage tiles, channels, etc., to any Waters of the U.S. (WOUS). Additionally, there are no known ecologic pathways or connections with any WOUS. Therefore, the wetlands in question are isolated, not susceptible to use in interstate or foreign commerce, and are not considered WOUS. This Determination supersedes the previous Determination issued on 7/25/2018.
