Typical year assessment(s): The Antecedent Precipitation Tool (APT) was used to evaluate climatic conditions for the date the consultant completed the delineation field work, June 14, 2020. The APT analysis shows that precipitation and climatic conditions were within the normal periodic range, therefore typical year conditions were present. Additionally, NOAA rainfalls records were obtained

from the weather station located at the Taylor County Airport for dates prior to the site visit. Records show 0.45 inches of precipitation fell during the 3 days prior to the site visit, and 0.14 inches fell on the date of the site visit. No water was observed in Stream 3 during the field delineation. As typical year conditions were present, and no flow was observed in Stream 3 following 0.45 inches of rainfall in the preceding 3 days, the assessment provides further evidence that Stream 3 is an ephemeral feature.
