This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The wetlands and associated off-site Weil Ditch provides habitat for aquatic fauna and benthic organisms that are vital to the support of the foodwebs associated with the Wabash River in a watershed that is dominated by agricultural activity.

ADDITIONAL COMMENTS TO SUPPORT JD:** Wetlands 1 (0.4 acre) and 4 (0.03 acre) directly abut and have discrete flow into an off-site non-RPW (Weil Ditch) which flows into the Wabash River (TNW) via Wildcat Creek (RPW). Wetland 4 begins at a culvert under U.S. 421 that drains a larger wetland system west of the highway into wetland 4, which continues off-site into Weil Ditch. Wetland 2 (2.6 acres) is located in a topographic "bowl" and does not flow outside of its delineated boundaries. To the south of Wetland 2 is a wide area of higher elevation. Wetland 3 (0.09 acre) is located between U.S. 421 and an old railroad bed. It does not flow to the south due to both an area of higher elevation and an access drive that does not have a culvert. There are no possible surface or subsurface hydrologic connections from wetlands 2 and 3, such as a swales, drainage tiles, channels, etc., to any Waters of the U.S. Additionally, there are no known ecologic pathways or connections with any

Waters of the U.S. Therefore, wetlands 2 and 3 are isolated with no hydrologic or ecologic connection to Waters of the U.S., and they are not susceptible to use in interstate or foreign commerce
