- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain:

The review area was visited by the applicant's consultant Summit Engineering, Inc. (Summit) in January 2012. Following the submittal, USACE personnel visited the site on August 27, 2012. Based on the site visit and information provided by Summit, the review area contained three (3) isolated seasonal-RPWs and three (3) upland areas. The isolated reaches included in this Approved Jurisdictional Determination are HLF-1 (545 linear feet), R2 of HLF-1 (300 linear feet), and L3 of HLF-1 (300 linear feet). These tributaries are located upstream of an existing road construction hollow fill. The upstream limit of the fill is located at Lat: 37.328633, Lon: -82.346839 where the defined channel of HLF-1 begins. From this point upstream, the seasonal RPWs are geographically isolated with no surface hydrologic connection either directly or indirectly to a TNW. The area has been previously disturbed by Department of Transportation activities, spoil disposal, timber harvest and gas exploration. The previous disturbance has disconnected and isolated the tributary to the upper reaches of the watershed. Approximately 2,850 linear feet of stream has been filled by the existing hollow fill with no evidence of a rock underdrain to maintain a hydrologic connection. No flow was observed at the toe of the existing fill or in the perimeter ditches of the hollow fill. There is no connection to interstate or foreign commerce.

Additionally, the upland areas included in this determination are Upland L1, Upland L2 and Upland R1 and are within the Houselog Fork drainage basin. These areas are simple depressions in the topography with no evidence of overland flow or channelized flow. Water was not present in these features and no indicators were present to suggest historic flow events had occurred. Based on these observations and the information submitted to this office, these areas are considered upland areas with upland soils and vegetation, which are not within our jurisdiction. Upland L1 is located at Lat: 37.327520, Lon: -82.346406. Upland L2 is located at Lat: 37.328223, Lon: -82.346877. Upland R1 is located at Lat: 37.327485, Lon: -82.345574.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
