If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?



ADDITIONAL COMMENTS TO SUPPORT JD: The identified forested wetland "Section I" (0.06 ac) captures surface runoff from the immediately surrounding areas to the east-southeast and drains west where it is topographically confined by an existing parking lot. Emergent wetland "Section II" (0.12 ac) captures surface runoff from the immediately surrounding areas to the west and north and drains to the southwest where it is topographically confined by a newly constructed on-ramp from US 31 to I-465. Prior to construction of the new ramp, the wetland was previously confined at the old location of the ramp, as shown in the aerials included with the 8/31/16 wetland delineation. There are no other possible surface or subsurface hydrologic connections from any of the wetlands, such as a swales, drainage tiles, channels, etc., to any Waters of the U.S. Additionally, there are no known ecologic pathways or connections with any Waters of the U.S. Therefore, the wetlands in question are isolated with no hydrologic or ecologic connection to Waters of the U.S., and they are not susceptible to use in interstate or foreign commerce.
