Explain: **USACE staff conducted an onsite assessment of the project area on March 17, 2016. Based on the site visit and the information provided by the applicant, the review area is considered an upland and is depicted on the generated map. The area included in this approved jurisdictional determination is identified as Upland Area .**

Evidence of historical confined surface flow was not present at the site and no defined bed/bank or OHWM was visible. The site has been impacted by historical surface mining, excess material disposal, timbering and oil/gas production and the review area is currently an abandoned mine pit and spoil disposal fill. This assessment was for the existing pit and immediately adjacent areas. Based on these observations this area is considered an upland area with upland soils and vegetation, which is not within the jurisdiction of the Corps. The approximate center of the Upland Area can be found at Lat: 37.42694 Lon: -82.74809. .

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
