C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The identified emergent wetland totals 0.44 acres and was delineated by USACE (the submitted delineation was inaccurate and did not identify the wetland). It is located in a topographic "bowl" and does not drain in any particular direction due to the fact that it is surrounded on every side by higher topography. Aerial imagery indicates that the site is not usually farmed due to seasonally inundation. No potential hydrologic connections (such as swales, channels, ditches, drainage tile, etc.) were observed, and there is no documented ecologic connection to Waters of the U.S. Therefore, the wetland in question is isolated with no hydrologic or ecologic connection to Waters of the U.S. and is not susceptible to use in interstate or foreign commerce.
