Two culverts enter the property from the south through the berm and are believed to convey stormwater runoff

from Winchester Road onto the property. There was no evidence of a defined channel from Culvert #1, nor was there any ordinary high water elevation within the culvert. The area surrounding Culvert #1 consisted entirely of uplands, with no evidence of any hydrological connection between the culvert outlet and the impounded tributary. Therefore, Culvert #1 and the vicinity are entirely upland with no water present.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
