emergent 0.251 ac wetland. The isolated wetlands exhibit no hydrologic connection or adjacency to any stream or other "waters of the United States" and are not susceptible to use in interstate or foreign commerce.

Wetlands A and B are forested wetlands located in the northern portion of the parcel in a depressional area. The area has an abandoned house located in the upland area between the two wetlands and surrounded by agricultural lands on all four sides. The areas are isolated with no hydrologic connection to any waters of the U.S.

Wetland C is a large emergent/scrub shrub wetland on the western edge of the property. The wetland is located in a depressional area partially contained within the farm field and the buffer area separating the farm field and the subdivision to the west. The area is isolated with no hydrologic connection to any waters of the U.S.

Wetland D is a small emergent wetland located in a depressional area on the northwest corner of the property. This area collects water from the agricultural field as well as the development to the north and residential subdivision to the west. The area is isolated with no hydrologic connection to any waters of the U.S.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetland A is a 0.312 ac forested wetland., Wetland B is a 0.813 ac forested wetland, Wetland C is a 1.283 ac. emergent/scrub shrub wetland and Wetland D is an emergent 0.251 ac wetland. The isolated wetlands exhibit no hydrologic connection or adjacency to any stream or other "waters of the United States" and are not susceptible to use in interstate or foreign commerce.

Wetlands A and B are forested wetlands located in the northern portion of the parcel in a depressional area. The area has an abandoned house located in the upland area between the two wetlands and surrounded by agricultural lands on all four sides. The areas are isolated with no hydrologic connection to any waters of the U.S.

Louisville District, Sheffield Park Subdivision, LRL-2015-371-sam, Isolated Wetlands

Wetland C is a large emergent/scrub shrub wetland in on the western edge of the property. The wetland is located in a depressional area partially contained within the farm field and the buffer area separating the farm field and the subdivision to the west. The area is isolated with no hydrologic connection to any waters of the U.S.

Wetland D is a small emergent wetland located in a depressional area on the northwest corner of the property. This area collects water from the agricultural field as well as the development to the north and residential subdivision to the west. The area is isolated with no hydrologic connection to any waters of the U.S.
