# 2. Non-regulated waters/wetlands (check if applicable):<sup>3</sup>

Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Seven wetlands totaling 0.54 acres were identified onsite (Wetland 1 – 0.03 acre; Wetland 2-0.04 acres, Wetland 3 – 0.09 acres, Wetland 4-0.07 acre, Wetland 5-0.04 acre, Wetland 6-0.11 acre, Wetland 7,0.16 acre). These wetlands are located along the base of a railroad bed that runs through an active gravel operation. The isolated wetlands exhibits no hydrologic connection or adjacency to any

stream or other "waters of the United States" and are not susceptible to use in interstate or foreign commerce.

Wetlands 1, 2, and 3 are emergent/scrub shrub wetlands that have formed as a result of drainage from the railroad bed and grading for adjacent mining operations. There are no hydrologic connection to any waters of the U.S. and should be considered isolated.

Wetlands 4,5,6 are emergent/scrub shrub wetlands that appear to be have formed in areas that were once headwater streams prior to the mining operations. The mining operations were previously permitted to impact these headwater streams. As such, they no longer exist. The wetlands that have now formed in the headwater areas are due to remnants for drainage from the mining site and the railroad. There are no hydrologic connections to any waters of the U.S and should be considered isolated.

Wetland 7 is a palustrine emergent wetland that is a linear feature where what drains from nearby quarry operation and the railroad tracks. There are no hydrologic connections to any waters of the U.S. and should be considered isolated.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ## C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?
