Wetland A has no hydrologic or ecologic connection to any stream or other "waters of the U.S." and is not susceptible to interstate or foreign commerce. A 0.3 acre pond, identified as "Cattle Pond," is a man-made open water feature constructed in uplands for an ongoing cattle operation. A 4.8 acre borrow pit is a man-made open water feature that was excavated in uplands to provide fill for the

construction of Overpass Road. The cattle pond and borrow pit have no hydrologic or ecologic connection to any streams or other “waters of the U.S.” and are not susceptible to interstate or foreign commerce, therefore are considered isolated open-water features and are not jurisdictional “waters of the U.S.” A 2,600 linear foot non-wetland swale located in a farm field and does not exhibit a defined bed and bank, an Ordinary High Water Mark (OHWM), nor is it susceptible to interstate or foreign commerce; therefore is not a jurisdictional “water of the U.S.”

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:





A 0.3 acre pond, identified as "Cattle Pond," is a man-made open water feature constructed in uplands for an ongoing cattle operation. A 4.8 acre borrow pit is a man-made open water feature that was excavated in uplands to provide fill for the construction of Overpass Road. The cattle pond and borrow pit have no hydrologic or ecologic connection to any streams or other "waters of the U.S." and are not susceptible to interstate or foreign commerce, therefore are considered isolated open-water features and are not jurisdictional "waters of the U.S." A 2,600 linear foot non-wetland swale located in a farm field and does not exhibit a defined bed and bank, an Ordinary High Water Mark (OHWM), nor is it susceptible to interstate or foreign commerce; therefore is not a jurisdictional "water of the U.S."
