If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:



ADDITIONAL COMMENTS TO SUPPORT JD: The wetland and pond that are being assessed within the applicant's property boundary is part of a complex of PEM, PSS, and PFO wetlands that abuts an off-site, seasonally intermittent, unnamed tributary of Pennsylvania Run, a perennial RPW. Topographic maps indicate that there was a topographical feature that would drain water through the middle of the property, which was dammed up to create the 0.6 acre open water pond. This stream continued down and converged with another intermittent stream in what is now a PSS portion of the wetland complex. The pond is still connected to the the downstream wetland and unnamed tributary via a linear wetland/swale that flows from the outlet of the pond into the portion of PEM wetland that is off-property. The channel has an OHWM as it leaves the PSS wetland that is dominated by Typha sp and flows directly into Pennsylvania Run, a RPW tributary of the Salt River, a TNW.
