Explain: The JD request is for an excavated upland man made pond measuring 1.8 acres, with 0.00161 acre fringe wetland. Historical aerials indicate the pond was excavated sometime between 1969 and 1979, likely for borrow to construct the nearby SR332 road. As can

be seen in aerials, the pond was excavated entirely in uplands, does not capture or contain any waters of the U.S., and is not located adjacent to or drain to any waters of the U.S. The pond is completely surrounded by upland agricultural land and is approximately 0.75 mile from the nearest stream. The pond sits on the watershed boundary. No ecological connection is present. The pond does not appear to be used, or susceptible to use for interstate or foreign commerce. Therefore, the pond appears to be a man-made excavated feature constructed in uplands and is not a waters of the U.S. No other aquatic resources are located on the 38 acre parcel.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.


