Explain: Approximately 7.9 acres of forested wetlands were located within an approximate 20 acre parcel by the Natural Resource Conservation Service(NRCS). Data provided by the Indiana Department of Environmental Management indicates that the wetlands are likely much larger than the NRCS delineation indicates. A large portion of the site has been mechanically cleared by the landowner.

A site visit conducted by Corps personnel confirmed that more wetlands are likely onsite than the original delineation by NRCS. A perforated tile with a standpipe was located in the adjacent agricultural parcel to the north. Soil conditions around this tile did not support hydric soils. No hydrology was visible around the tile. The corps did not have permission to walk across the adjacent parcel, so no outlet could be identified for any hydrologic connection. There was no clear evidence of any water flowing from the wetland to the standpipe on the adjacent parcel. The area that had been cleared appeared to be slightly lower than the adjacent agricultural field, limiting any hydrologic connection.

The corps concludes that while we do not concur with the NRCS boundary of the wetland, the isolated wetland exhibits no hydrologic connection or adjacency to any stream or other "waters of the United States" and is not susceptible to use in interstate or foreign commerce.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
