Summarize overall biological, chemical and physical functions being performed: The wetlands provide some short term water storage from on-site runoff that provides more consistent flow for the intermittent UT of McFadden Creek. This water storage also allows for ground-water recharge and removal of nutrients from fertilizer use on the adjacent farm field.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?



B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland 3 and a portion of wetland 2 were likely part of the UT of McFadden Creek where the flow was impeded by the presence of phragmites sp. and typha sp. and was inundated for sufficient time and regularity to change the resource characteristics from stream to wetland. Wetland 1 is a continuation of wetland 3 and was differentiated by the consultant due to the differences in vegetation observed on-site. With these things in mind, it is apparent that wetlands 1, 2, and 3 about the RPW UT of McFadden Creek. McFadden Creek on the southeast corner of the property converges with the UT of McFadden Creek as it flows west along the south side of the property. The RPW portion of McFadden Creek turns into the TNW portion of McFadden Creek which then flows into the Ohio River, also a TNW.
