C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The 0.26-acre property in question contains an approximately 0.15-acre large wetland that generally flows southwest, ultimately under 6th Street and into a ditch that runs along the northwest-side of Greene Street. There are two culverts under Greene Street that can convey water from the ditch to the southwest. The northern culvert is currently full of gravel and is not functioning. The southern culvert could convey flows from the ditch to the southeast. Water could then potentially flow overland to the southeast but would be captured by a depressional basin that is dominated by willows located immediately northwest of an RV Park. This basin does not have an outlet. There is not a surface connection to a Traditional Navigable Water (TNW) and no evidence of a subsurface connection. The closest TNW is the Animas River, which is approximately 2,200-linear feet to the east. In 2005, Bio-Environs conducted a wetland delineation for the Town of Silverton, which included the property in question. Bio-Environs report identified three wetlands, totaling 1.7 acres. The Town of Silverton did not request a jurisdiction determination. On November 12, 2006,

Bill Simon requested an approved jurisdiction determination for the property in question. A wetland delineation for this property was not submitted. On January 4, 2007, the Corps determined that the wetlands located on the property were interstate, isolated wetlands with no nexus to interstate commerce. This determination expired on January 4, 2012. No changes have occurred since 2006 that would affect the non-jurisdictional status of these resources.
