Therefore, the channels within the delineation boundary are isolated, intrastate waters with no connection to interstate commerce and are not jurisdictional.

**C. SIGNIFICANT NEXUS DETERMINATION**

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

Drainages A-G flow towards but end 1-mile before reaching the Amargosa River and have no direct or indirect connection to a TNW. Based on the available information Drainages A-G have no hydrologic connection to the Amargosa River or any Water of the U.S. because of evapo-transpiration and infiltration. The area is relatively remote with limited services and virtually no water-dependent activities. The Corps found no evidence of water dependent interstate commerce within the Amargosa Valley and concluded that the drainages associated with the Reward Mine Project are all intrastate, isolated waters and are therefore non-jurisdictional.
