Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: There are ten review areas within this Approved Jurisdiction Determination (AJD) request, totally 43.22 acres. Within the nine AJD review areas, 18 individual waters, totally 0.30 acre, have been identified. These waters include septic lagoons, irrigation and drainage ditches, and stock ponds. CFR § 328.3, waste treatment systems, including treatment ponds or lagoons designed to meet the requirements of the Clean Water Act are not waters of the United States. Therefore, W-6 and W-11 are not waters of the US.

Features W-14-a, W-14b, W-74 through W-83, and W-22 are irrigation and/or drainage ditches excavated wholly in and draining only uplands and that do not carry relatively permanent flow of water. In accordance with the preamble to 33 CFR Parts 320 through 330, these features generally are not jurisdictional under the Clean Water Act, since these features do not act as tributaries.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
