C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Washes A1, A2, B4-B7, B9, B12, and B1.2 are all tributaries to an unnamed wash located to west of the California Wash. The western unnamed wash connects to California Wash approximately 2.5 miles downstream from the study area. Washes E1, and F2-F5 are all tributaries to an unnamed wash located to the east of the California Wash. The eastern unnamed wash connects to California Wash approximately 3 miles downstream from the study area. Washes B1-B3, B10, B11, C1-C4, D1-D11, E3, F1, F6, and F7 all connect directly to California Wash. California Wash is a non-RPW tributary to the Lower Muddy River, the nearest RPW, which flows into Lake Mead, which is the nearest TNW.

These washes are all waters that have limited ephemeral surface water flow, and do not support recreation, fishery, commercial, or industrial uses. No interstate commerce connections were found that would be adversely affected as a result of degradation or destruction of these waters. While storm events that result in water flows within these channels between are infrequent, they are of such an intensity that they have created continuing OHWM and bed and bank features throughout the entirety of the subject drainages, connecting them to the RPW downstream. Though the tributaries within the project area are ephemeral, and as such, do not support or have suitable habitat for aquatic species, during major storm events there is the capacity to transfer nutrients and organic carbon to support downstream food webs. These drainages, where there is a connection, also have the capacity to carry pollutants, sediments, or flood waters to the RPW and downstream TNW. While Lake Mead is not listed as an impaired water, the phosphorus waste load allocation has been exceeded at various times due to nonpoint source contributions.

In summary, Washes A1, A2, B1-B7, B9-B12, B1.2, C1-C4, D1-D11, E1, E3, and F1-F7 have been determined to have more than a speculative or insubstantial nexus on the chemical, physical and/or biological integrity of the nearest TNW. These drainages are jurisdictional waters in those locations where OHWMs are exhibited within the project area.
