Drainage Ditch segment through SSJID Irrigation Lateral Tb-AA, SSJID Drain AA, SSJID Dual-Use Lateral, French Camp Outlet Canal, French Camp Slough and into the San Joaquin River, a navigable water of the US in its lower reaches.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD: Drain 5 is part of the SSJID irrigation network which conveys irrigation water from SSJID reservoirs behind Tulloch, New Melones, Beardsley, Goodwin and Donnell's Dams to downstream users. Drain 5 also conveys excess irrigation flows and stormwater flows from the City of Manteca through French Camp Outlet Canal, French Camp Slough for discharge into the San Joaquin River, a navigable water of the U.S. in its lower reaches.**
