This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This office does not concur with the February 15, 2008, Preliminary Delineation of Waters of the United States, Including Wetlands for the North Fork American River Trail Project, submitted by EDAW, Incorporated. However, this office does concur with the February 12, 2008, revised September 29, 2008, Wetland Delineation Maps 1-6, submitted by EDAW, Incorporated.

D1 through D15, D17 through D19, D27 through D33, D35 through D48, 620, 622, and 649 are similarly situated ephemeral waters which have a flashy discharge regime during the winter and are dry during the summer and discharge directly into the North Fork American River. D16 and D34 (not included) are seasonal RPWs flowing more than three months of the year. D20 through 26 are not included in this delineation as the proposed trail alignment has changed since the previous delineation.
