C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

flow from the delineated wetland to an unnamed tributary to Dry Creek, located a few hundred feet from the wetland, does not exist. The swale becomes flat prior to reaching the tributary. It appears any flow from the wetland area goes subsurface before it reaches the tributary. Hydrophytic vegetation within the wetland area is marginal in some areas and very predominant in other areas. The Corps suspects that the wetland hydrology is influenced by the irrigation canal and water is conveyed via porous sills within the soil profile. The applicant did not supply any information regarding the source of hydrology.

Due to its small size (0.44 acres), its position in the landscape (slope wetland surrounded by upland agricultural land), and sporadic marginal wetland characteristics, the wetland system does not have a significant nexus to a traditional navigable waterway, which is located approximately 15 aerial miles away.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The 0.44 acre wetland in question is a slope wetland located within an upland swale below a large irrigation canal. The wetland area is located approximately 400 feet from the nearest relatively permanent waterway. There is no evidence of flow (such as scour marks, drift lines, sedimentation, flattened vegetation, etc.) from the wetland to the RPW. Upland vegetation and a flattened slope exist between these two systems. It appears any flow from the wetland area goes subsurface before it reaches the tributary. Hydrophytic vegetation within the wetland area is marginal in some areas and very predominant in other areas. It is suspected that the wetland hydrology is influenced by the irrigation canal and water is conveyed via porous sills within the soil profile. Information to confirm the source of hydrology is not available. The nearest RWP is an unnamed tributary to Dry Creek, approximately 400 feet from the wetland. This tributary is heavily influenced by irrigation waste water. Dry Creek is tributary the Los Pinos River, which flows into the Navajo Reservoir, a Section 10 waterway. The approximate distance between the wetland in question and the Navajo Reservoir is approximately 15 aerial miles.

ADDITIONAL INFORMATION SUPPORTING NJD (e.g., paragraph 1 - site conditions; paragraphs 2-3 - rationale used to determine NJD, including information reviewed to assess potential navigation or interstate commerce connections; and paragraph 4 - site information on waters of the U.S. occurring onsite): The wetland area in question is located within an intermittent drainage swale directly below an irrigation canal. This swale does not contain evidence of an OHWM, scour marks, debris flow, sedimentation, etc. It is an upland depressional feature. Evidence of flow from the delineated wetland to an unnamed tributary to Dry Creek, located 400 feet from the wetland, does not exist. The depressional upland swale disappears and the topography becomes flat prior to reaching the tributary. It appears any flow from the wetland area goes subsurface before it reaches the tributary. Hydrophytic vegetation within the wetland area is marginal in some areas and very prominent in other areas. I suspect that the wetland hydrology is influenced by the irrigation canal and water is conveyed via porous sills within the soil profile. The applicant did not supply any information regarding the source of hydrology.

The 0.44 -acre seasonal wetland has no surface hydrology connection to other waters of the U.S. based on topographical constraints. It is therefore considered intrastate and isolated.

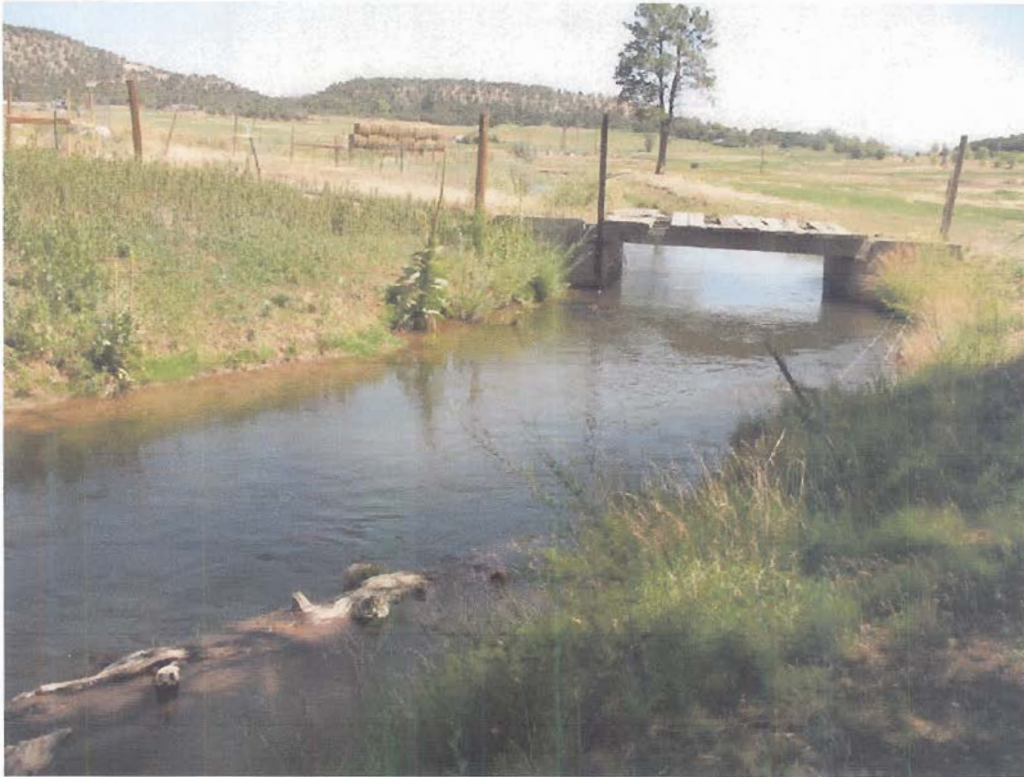


Figure 1 Irrigation ditch located above the site

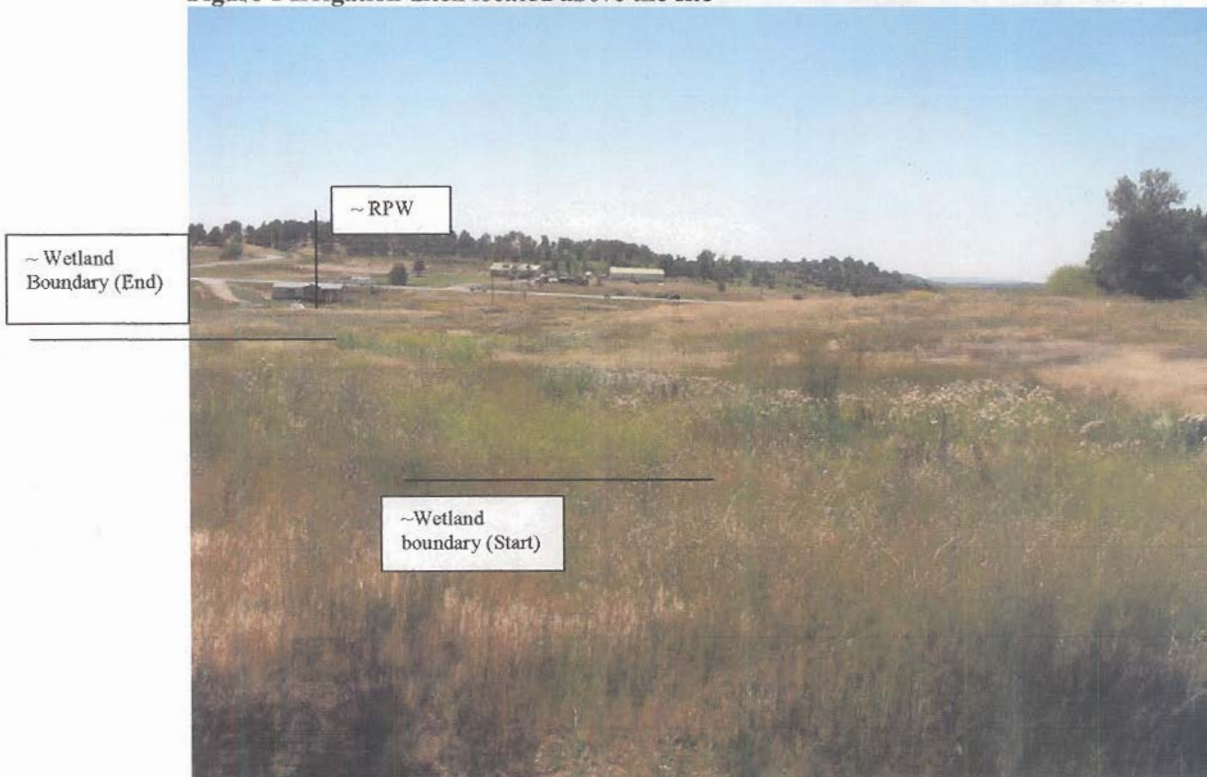


Figure 2 Looking at wetland area from irrigation ditch

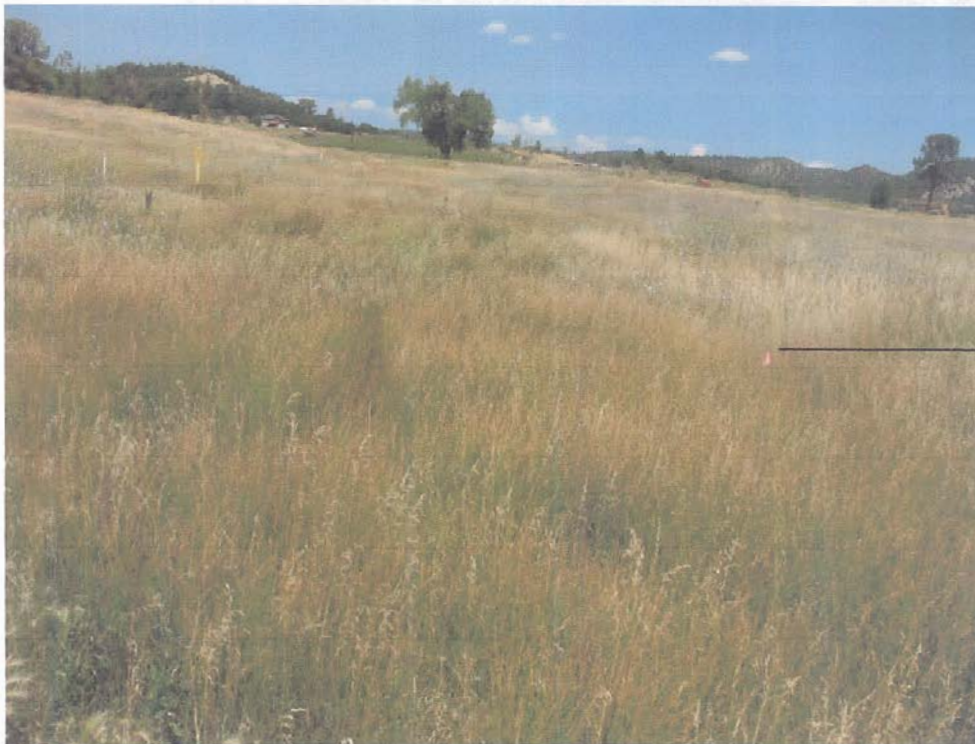
