**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This is a complicated site. There is standing water present in November. The original JD required a hydrologic study which indicated that much of the site was influenced by upland irrigation. One of the wetlands identified overlaps onto this site which is a subset of the larger site. The south wetland appears to be isolated from the small tributary of the Uncompahgre River that is abutting the north wetland. There is a section of property that does not support a dominance of wetland vegetation between the two mapped wetlands. Since the water is still present in November, quite a while after irrigation has been shut off, it is probably fed from underground hydrology originating in springs/seeps upgradient .

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The drainage goes underneath county road 23 in a culvert into a ditch that runs northward where it connects with the ditch containing Cottonwood Creek and then to the Uncompahgre River.

**A previous JD was verified for the larger town park site in 2000. The approved map is missing from the file and the converted ORM file indicates that the only wetland identified prior to park development was isolated and the water was from irrigation.**
