The ditch was constructed and maintained by the Solano Irrigation District. In the mid to late 1990's the District rerouted irrigation water through underground pipelines and rendered the ditch inoperable and has abandoned the ditch. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

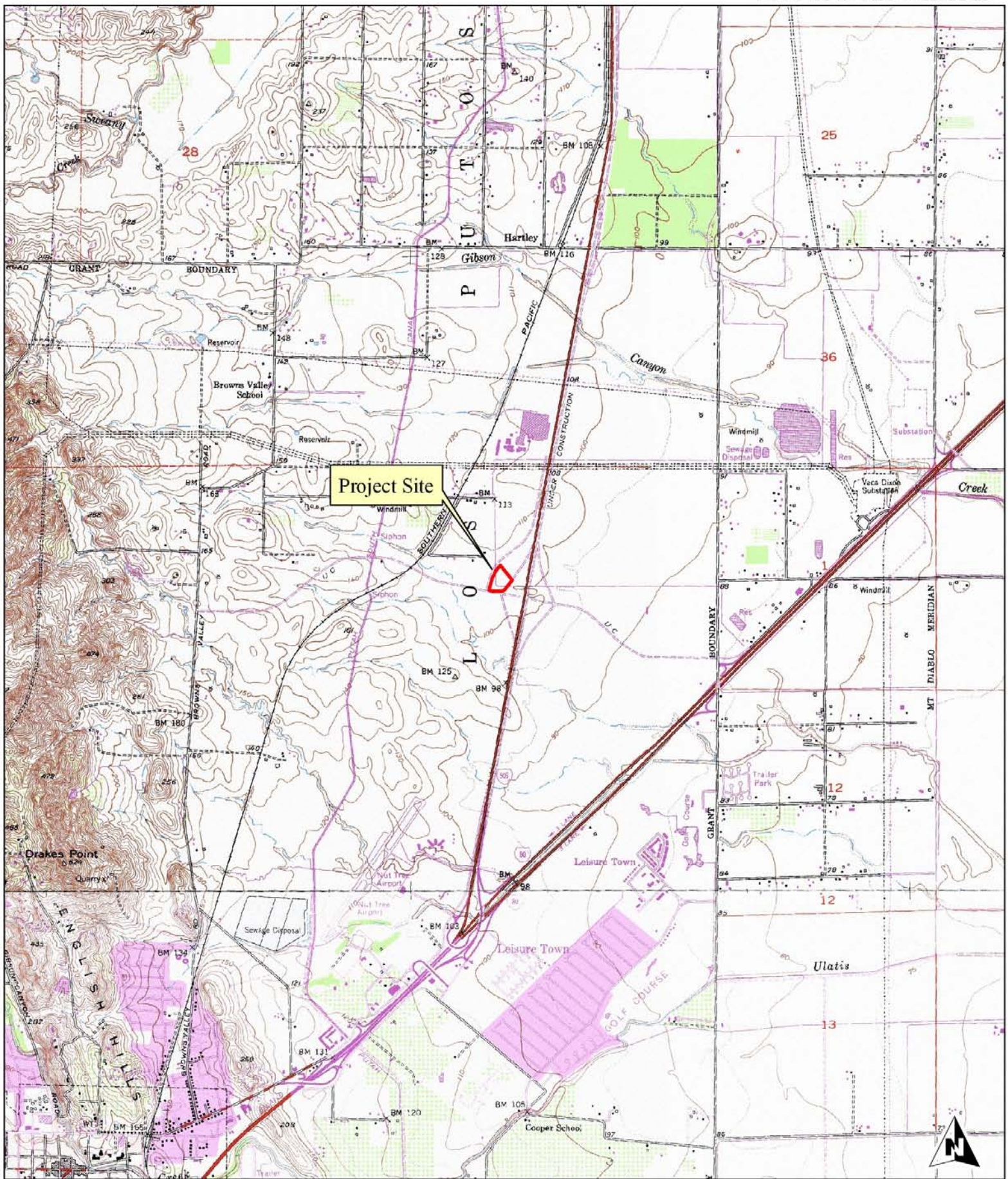

The site is located at the off ramp east of Interstate Highway 505 at the Vaca Valley Parkway exit. It is between Vaca Valley Parkway, Crocker Drive and the rest of the open field to the north and east adjacent to the off ramp.

There is an abandoned irrigation ditch onsite that was determined to not be a water of the US because it does not have an ordinary high water mark and it has no downstream connection. Both upstream and downstream connections were severed in the mid 1990's by the Solano Irrigation District, owner of the ditch. The onsite reach was abandoned and then sold along with the rest of the 4.6-acre property, in 2006. The seasonal wetland complex appears perched onsite without a downstream connection.

The 0.066-acre seasonal wetland complex has no surface hydrology connection to other waters of the U.S. based on topographical constraints. It is therefore considered intrastate and isolated.

There are no waters of the US occurring onsite. The ditch is not a water ,and the wetlands are isolated with no apparent interstate commerce connection, therefore, non-jurisdictional.



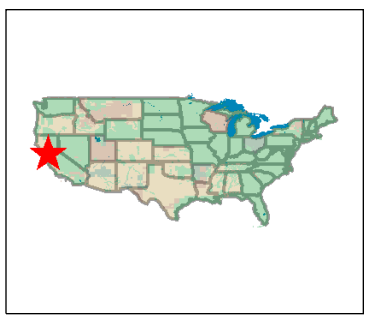
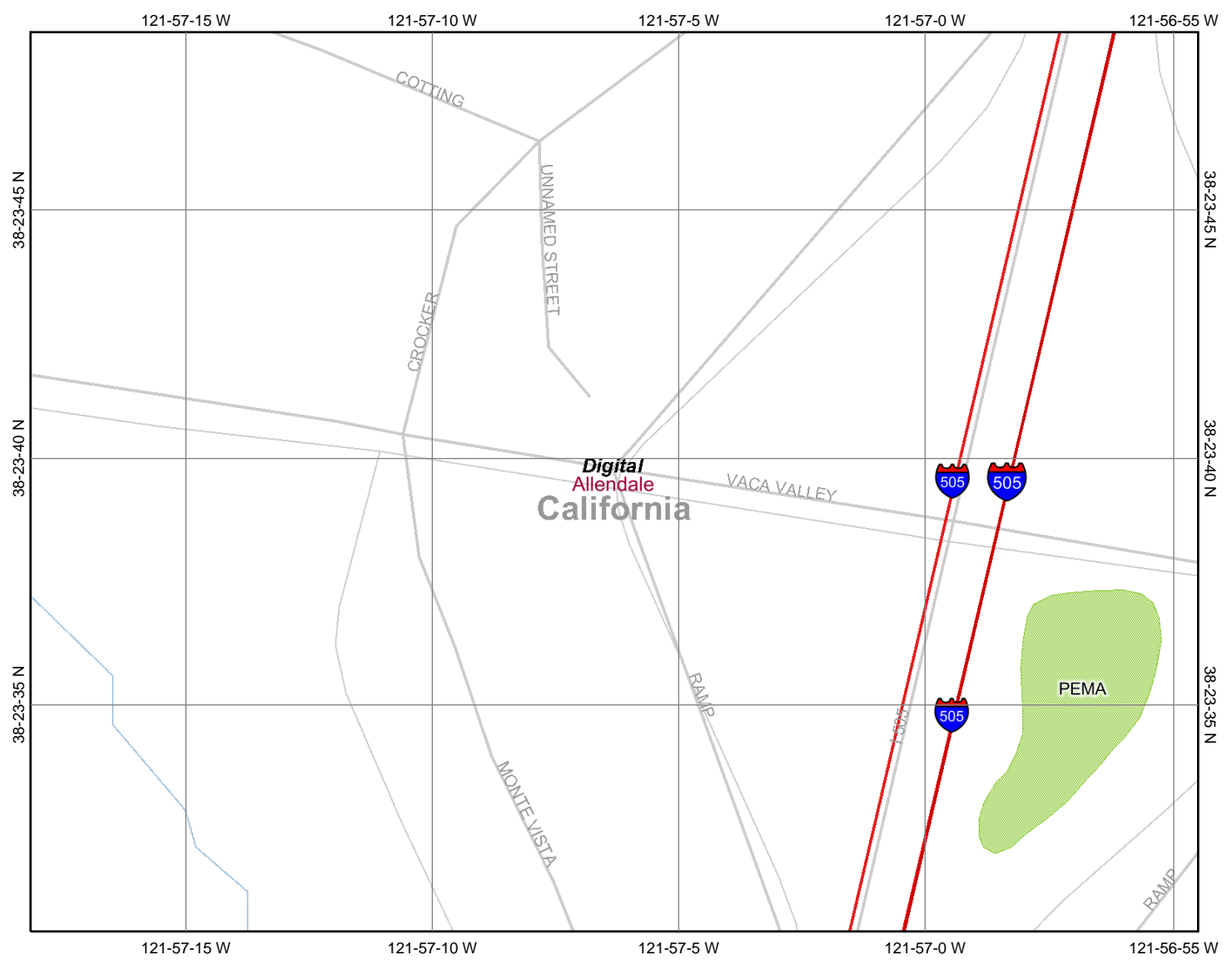
