### B. ADDITIONAL COMMENTS TO SUPPORT JD:

Description
Four wetland areas (A, B, C, and D) were identified in a wetland delineation report provided by the applicant's consultant. Two wetlands, A and B appear to be man-made excavated features. Wetlands C and D are slope wetlands that are apparently part of an old landfill that has been capped with clay. All of the wetlands identified appear to lack an outlet or any possible surface water connection to navigable waters. Contour lines as depicted on the attached wetland delineation map support this determination. The July 1980 7.5 Minute USGS Quadrangle (attached) shows a pond on the property with a stream connecting it to a system of ditches to the south. Aerial photos (attached) from 1997, 2003, and 2007 show that the site has been altered. Two site visits, one on December 26, 2007 and one on February 21, 2008 were conducted. Observations from the site visit support the finding that all four wetland areas are isolated from navigable waters.
