Prior to the Jan 2001 Supreme Court decision in "SWANCC," the review area would have been regulated based solely on the "Migratory Bird Rule" (MBR):

Waters do not meet the "Significant Nexus" standard, where such a finding is required for jurisdiction (Explain):

The project is located in a manipulated ephemeral drainage which does not meet the significant nexus standard. The ephemeral drainage is channelized, traveling north from the site where it crosses over the the CA aqueduct in a concrete channel. From this point flows enter a series of agricultural ditches and ultimately terminate several miles northeast of the project site in a large field dominated by saltbush scrub. A culvert leading into New Rim Ditch exists in the levee at the far side of the field into which flows drain away from the ephemeral drainage. Surface flows from the ephemeral drainage typically dissipate underground in the salt bush field, an area south of the New Rim Ditch. It is only when the entire field floods that water is able to enter the New Rim Ditch, an event normally occurring only during large storm events. The New Rim Ditch terminates 14 miles northwest of the site and does not connect with any waters downstream. Water collected in this New Rim Ditch is only used for localized irrigation. Land uses adjacent to the ephemeral drainage include grazing, agriculture, and industrial facilities. The industrial facilities do not utilize any water from the ephemeral drainage, therefore there is no interstate nexus for these waters.
