- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Twin Peaks Spring flows from its source 1000 feet to a stock pond. The water does not flow beyond the stock pond. If the pond were to over flow, the nearest drainage is a dry wash approximately 1 mile north of the spring. This dry wash proceeds another 3.5 miles to Clear Spot Flat which is a closed contour depression (4770). No defined drainages leave the flat and it is another 6 miles across flat desert terrain to the Beaver River. The Beaver River does not flow in Millard County and has not flowed in last 20 plus years. The nearest TNW is Minorsville Reservoir approximately 50 miles upstream on the Beaver River.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

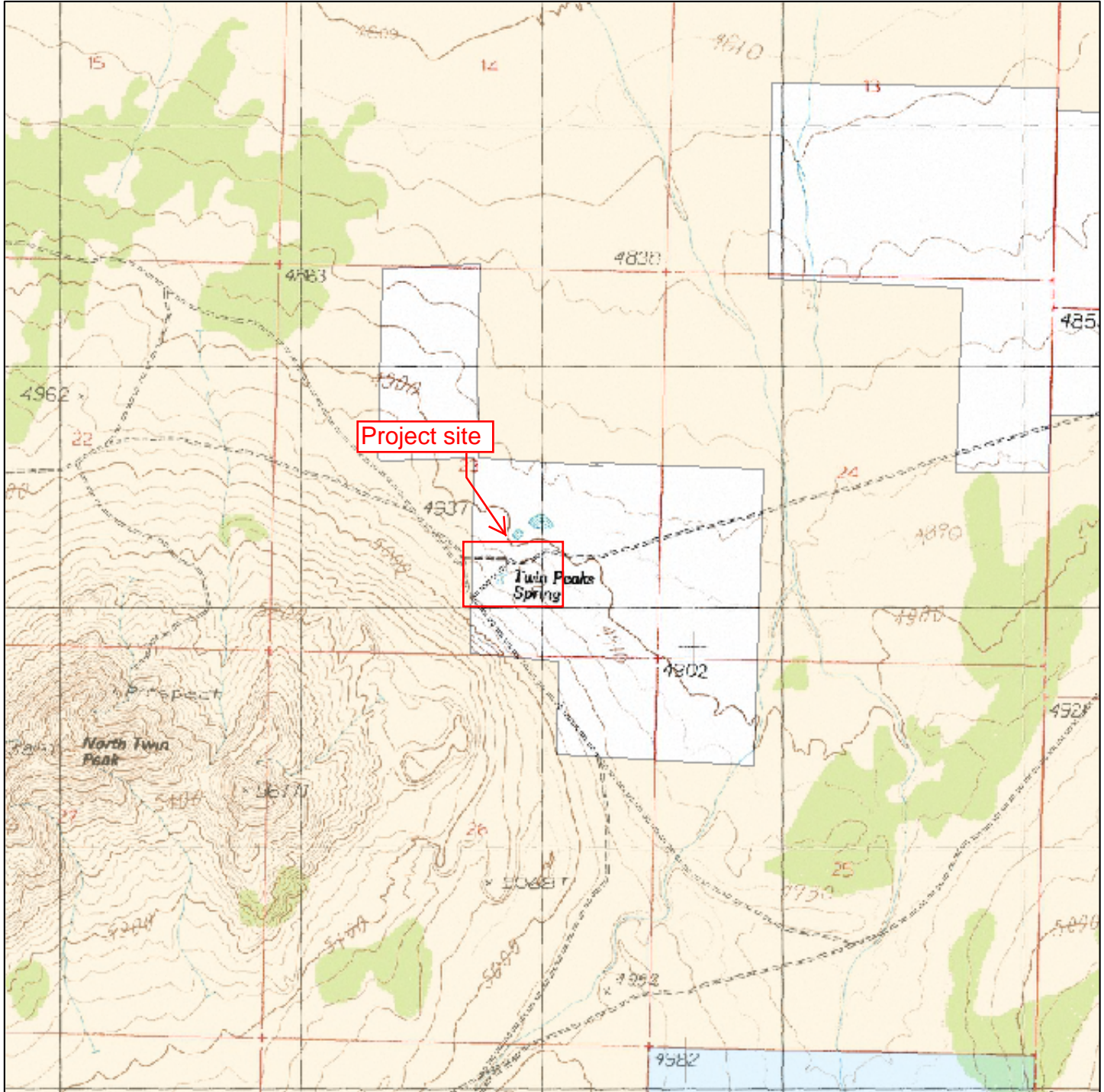

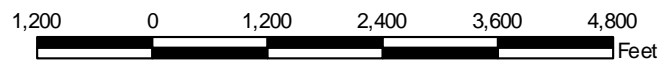
