- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.
Explain: **The 0.08 acre wetland occurs is a slight depression with upland conditions surrounding it. The wetland has developed from a seep which does not pond water or produce a surface flow condition down gradient from the wetland. South and down gradient from the wetland is a large field that has been farmed for decades and no ditches or swales are present that could convey water from this wetland to a RPW. The nearest wetland or flowing water to this wetland is a spring-fed drainage that surfaces near a grove of willows 560 feet northwest of the wetland and flows south west to a ditch along 4850 West Street. According to two local farmers, they have seen other local springs and seeps become drier as up-gradient land use practices have changed from irrigated agriculture to residential and**

commercial development. Aerial photographs of the area from the 1970's confirm their observations. There is no evidence of any interstate commerce connections associated with the project site as the land is fallow fields of the old farmstead that are no longer farmed.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

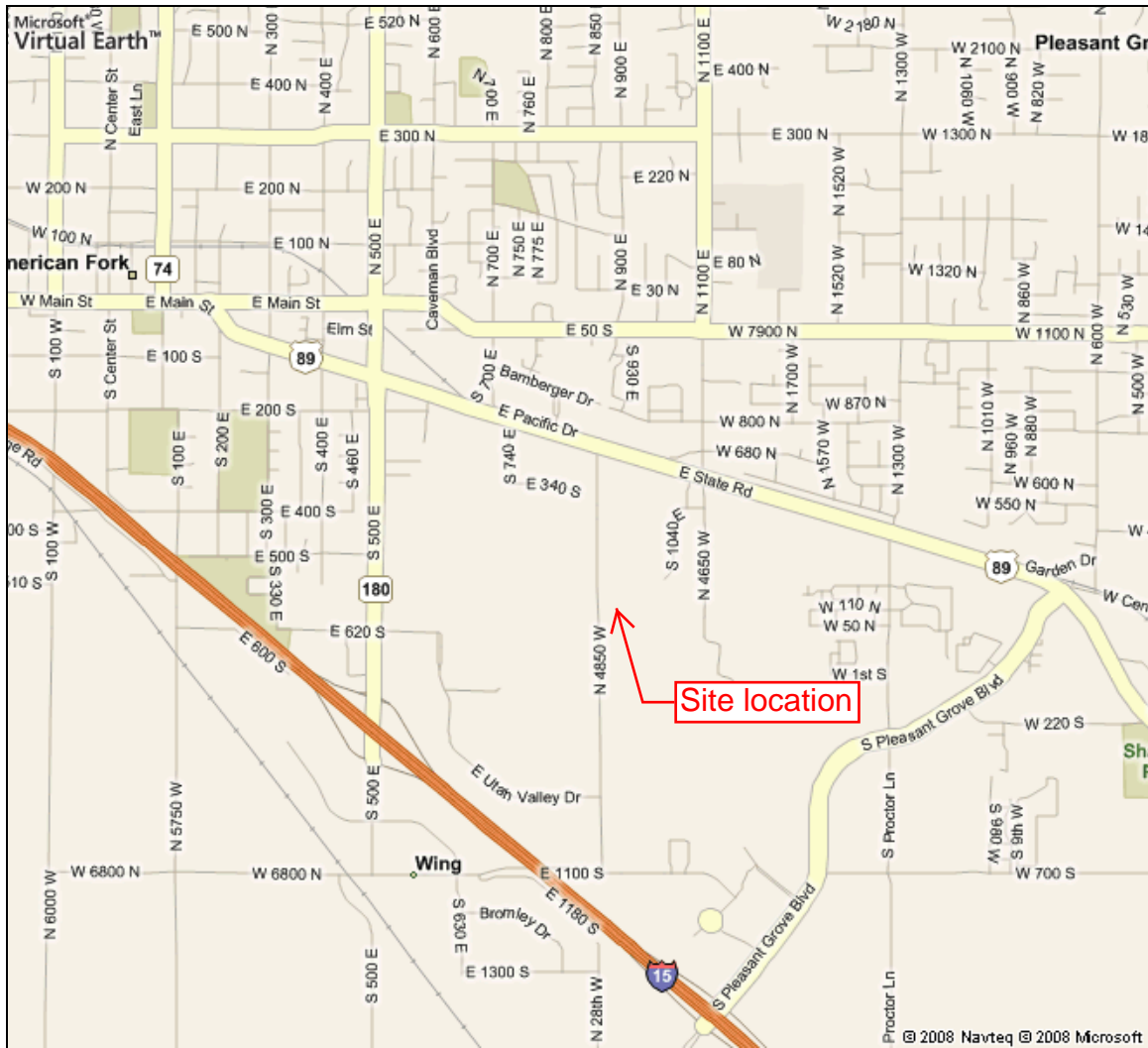

RPW: There is a perennial spring located on this property that produces enough water to surface flow across the property to a ditch that flow south along 4850 West Street. This unnamed ditch continues to flow south to Sam White Lane (6800 North) where it connects to Sager

Slough. Sager Slough flows under the I-15 freeway and continues for another mile where it empties into Utah Lake a traditional navigable waterway. The wetlands on the site are approximately 1-3/4 miles from Utah Lake. Corps personnel have observed perennial flows in the unnamed ditch at least four times during the past year.

Abutting wetlands: The wetlands directly connect to the spring fed RPW that surfaces and flows through this site. No upland barriers or berms separate the wetland from the waterway.

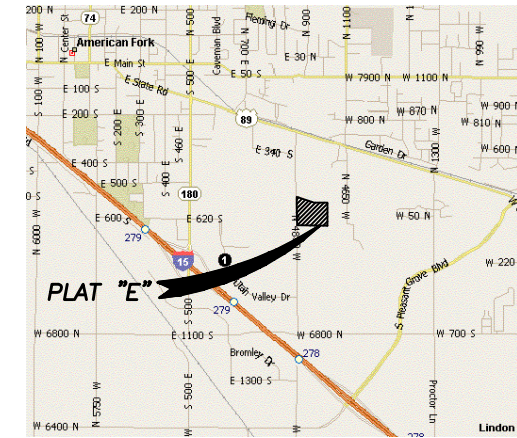
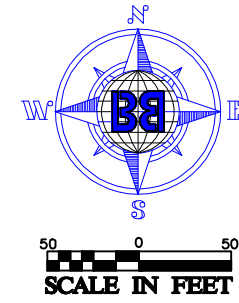
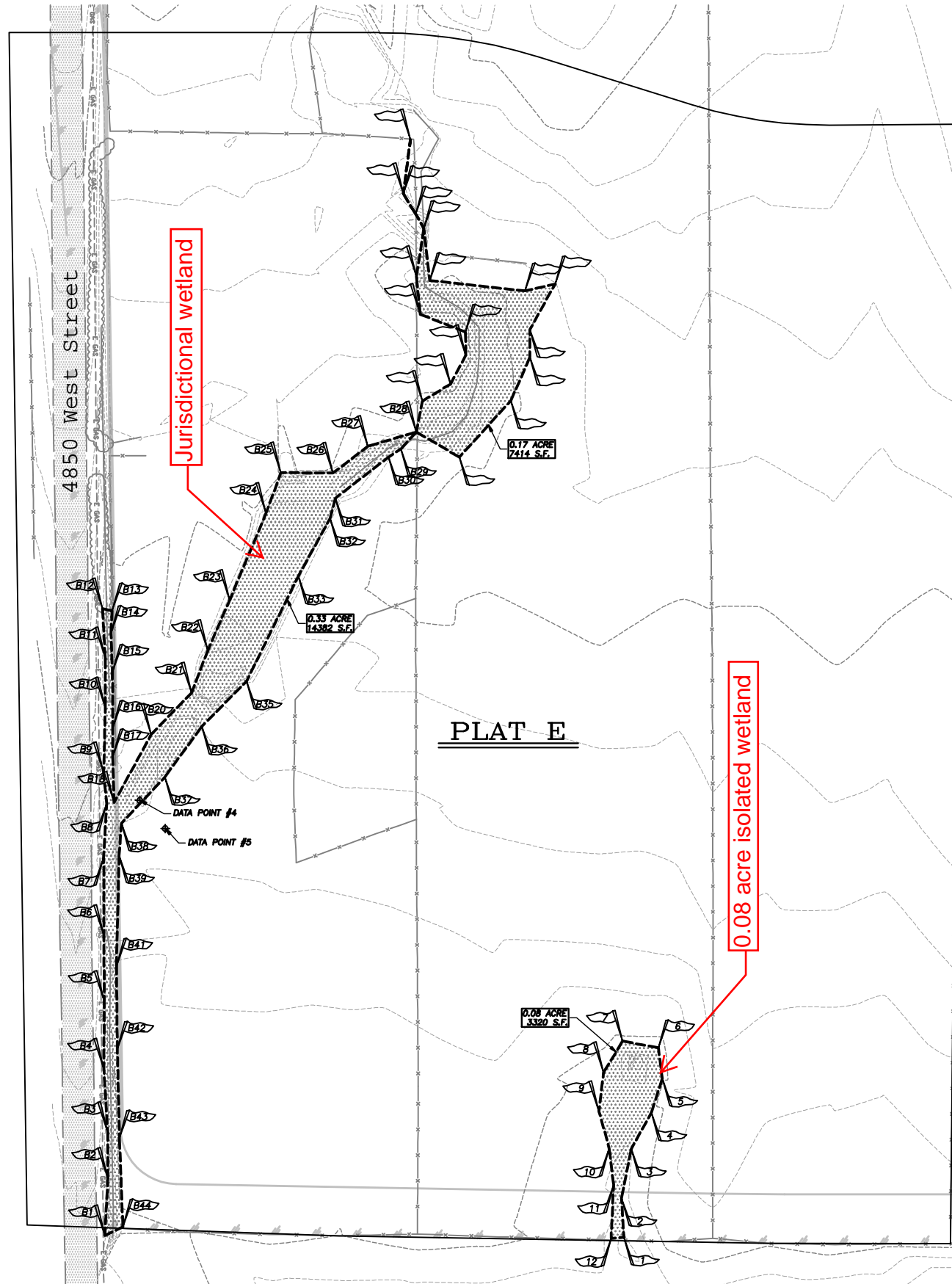
Site Vicinity Maps

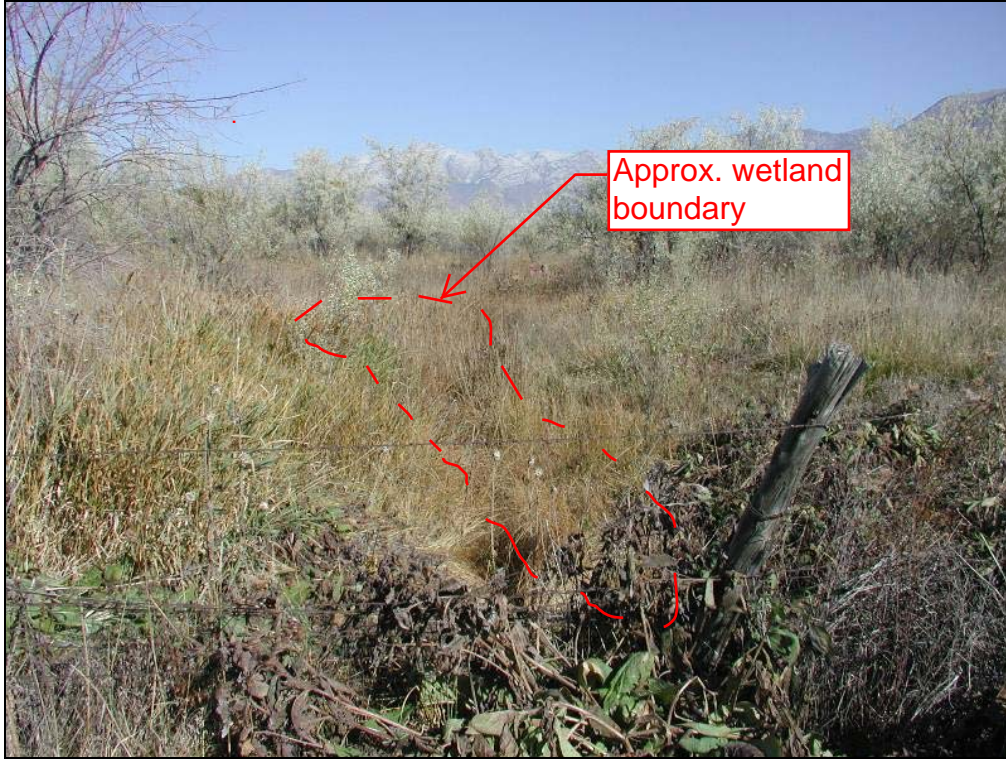
