This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Both the intake channel and Delta Mendota Canal are tidally influenced waters connected to Old River and are therefore both navigable in fact and subject to Section 10 of the Rivers and Harbors Act. The wetlands are adjacent to the Delta Mendota Canal separated from the canal by an earthen levee. The canal is unlined. The wetlands are most prevalent next to the levee. There appears to be no impermeable barrier between the canal and the location of the seasonal wetlands to prevent subsurface flow. Area identified on map as DF-1 is a shallow depressional feature immediately adjacent to but separated by a berm from an active irrigation ditch just outside of the study area. The feature did not meet the hydrophytic vegetation parameter for a wetland according to either the dominance test or prevalence index, though it did have hydric soils.
