Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: **Although the vernal pool complex within the Study Area has five features which meet the three criteria specified in the 1987 Corps of Engineers Wetlands Delineation Manual (hydrophytic vegetation, hydrology, and hydric soils), under the Rapanos/Carabell guidelines these features are isolated, have no significant hydrologic or ecological nexus to a TNW, and have no potential for interstate or foreign commerce. Vernal pools on this lot and adjacent lots do exhibit a regional drainage pattern (with vernal playas and swales evident on aerial photography). However, the features in question have no evidence of sustained flow, and their contributing watershed is too small to support a seasonal flow or to generate OHWM indicators. It is likely that the only time water would flow out of the pools is**

during periods of extreme inundation, and then only as overland sheet flow. The entire contributing watershed is only 57,750 square feet (the high point on the landscape is 350 feet from the center of the vernal pool complex in question, and the parcel is 165 feet wide.) The vernal pool complex is 668 feet from the unnamed roadside ditch to the west, and lacks a clear connection to the ditch. The ditch itself is not a RPW, and it drains in a westerly direction through a culvert to an unnamed tributary of North Fork Badger Creek, which has eventual connectivity to the Cosumnes River, a TNW. The vernal pool complex in question is situated several miles away from this TNW. Average annual rainfall for the area is approximately 20 inches, thus the water harvest for the contributing watershed is 2.2 acre feet annually. Owing to the small size of the contributing watershed, the assumed short duration of flow out of the complex (if any), and the lack of clear connectivity to a TNW, it has been determined that any effect the on-site wetlands may have on the physical, chemical or biological integrity of the Cosumnes River is speculative or insubstantial.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

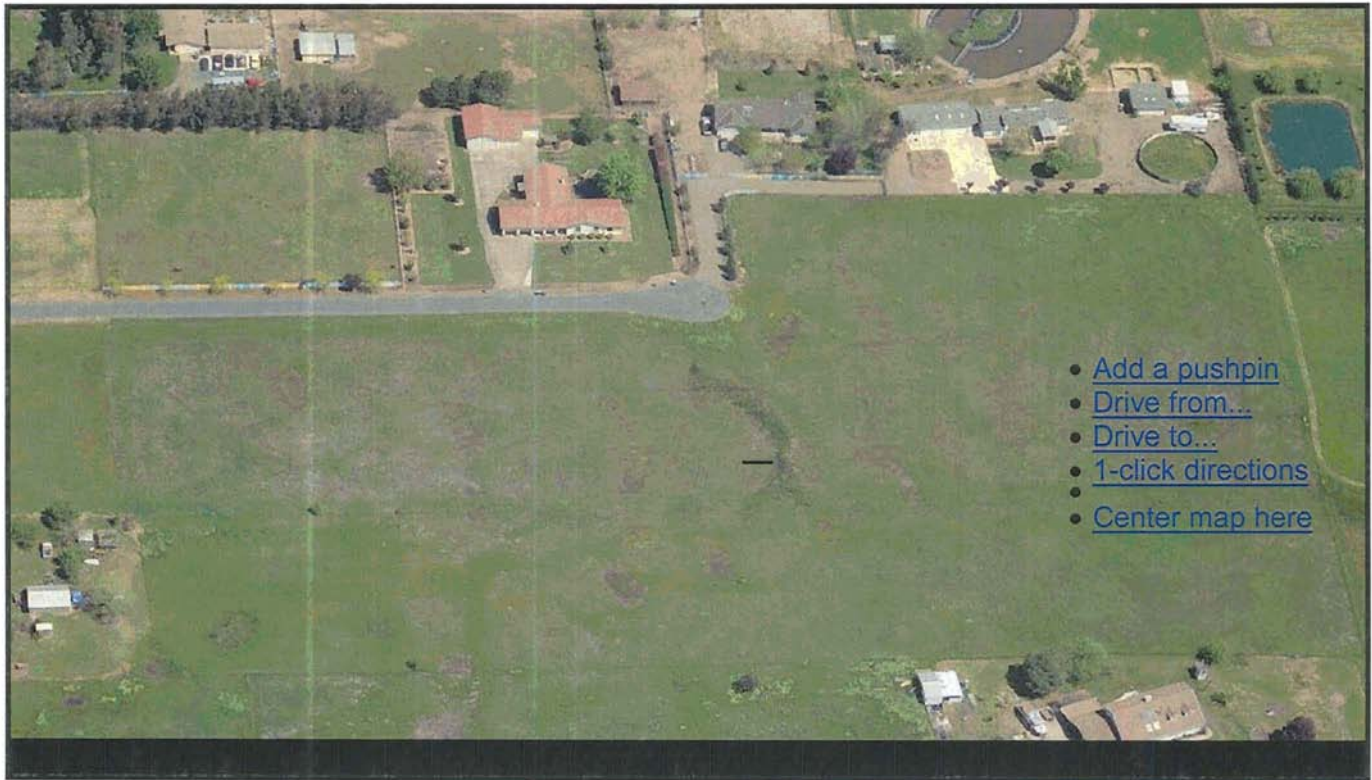

B. ADDITIONAL COMMENTS TO SUPPORT JD: Although the vernal pool complex within the Study Area has five features which meet the three criteria specified in the 1987 Corps of Engineers Wetlands Delineation Manual (hydrophytic vegetation, hydrology, and hydric soils), under the Rapanos/Carabell guidelines these features are isolated, have no significant hydrologic or ecological nexus to a TNW, and have no potential for interstate or foreign commerce. Vernal pools on this lot and adjacent lots do exhibit a regional drainage pattern (with vernal playas and swales evident on aerial photography). However, the features in question have no evidence of sustained flow, and their contributing watershed is too small to support a seasonal flow or to generate OHWM indicators. It is likely that the only time water would flow out of the pools is during periods of extreme inundation, and then only as overland sheet flow. The entire contributing watershed is only 57,750 square feet (the high point on the landscape is 350 feet from the center of the vernal pool complex in question, and the parcel is 165 feet wide.) The vernal pool complex is 668 feet from the unnamed roadside ditch to the west, and lacks a clear connection to the ditch. The ditch itself is not a RPW, and it drains in a westerly direction through a culvert to an unnamed tributary of North Fork Badger Creek, which has eventual connectivity to the Cosumnes River, a TNW. The vernal pool complex in question is situated several miles away from this TNW. Average annual rainfall for the area is approximately 20 inches, thus the water harvest for the contributing watershed is 2.2 acre feet annually. Owing to the small size of the contributing watershed, the assumed short duration of flow out of the complex (if any), and the lack of clear connectivity to a TNW, it has been determined that any effect the on-site wetlands may have on the physical, chemical or biological integrity of the Cosumnes River is speculative or insubstantial.
