This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Summarize overall biological, chemical and physical functions being performed: Seasonal Wetland may retain some precipitation, but not long enough to have evidence of ponding. Seasonal Wetland Swale collects overland flow and conveys flow directly to Secret Ravine. Saturation supporting hydrophytic vegetation is present and wetlands (Seasonal Wetland Swale) was observed abutting Secret Ravine.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

The wetland does not have the capacity to convey pollutants or flood waters to the Sacramento River as no pollutants were observed in the wetland and the wetland is located outside and above the floodplain of Secret Ravine. The wetland may have the capacity to reduce flood waters reaching the Sacramento River by ponding during precipitation events, although it does not have a large capacity due to its small size. The seasonal wetland does not provide habitat or lifecycle support for species present in the Sacramento River due to its distance from the Sacramento River and lack of long-term ponding. Secret Ravine does support species present in the Sacramento River as it is considered an anadromous fish stream. The seasonal wetland may have the capacity to transfer nutrients and organic carbon to downstream foodwebs. No surface connection to Secret Ravine was evident and evidence of shallow subsurface flow expressed in the location of hydrophytic vegetation just downslope of the seasonal wetland ended approximately 130 feet from Secret Ravine, however, water may overtop a shallow rise on the downslope side of the seasonal wetland and flow via overland sheetflow to Secret Ravine. Secret Ravine is tributary to Miner's Ravine, which is tributary to Dry Creek, which is tributary to the Natomas East Main Drainage Canal, which is tributary to the Sacramento River, a navigable water of the U.S.
